Know what you're getting into.



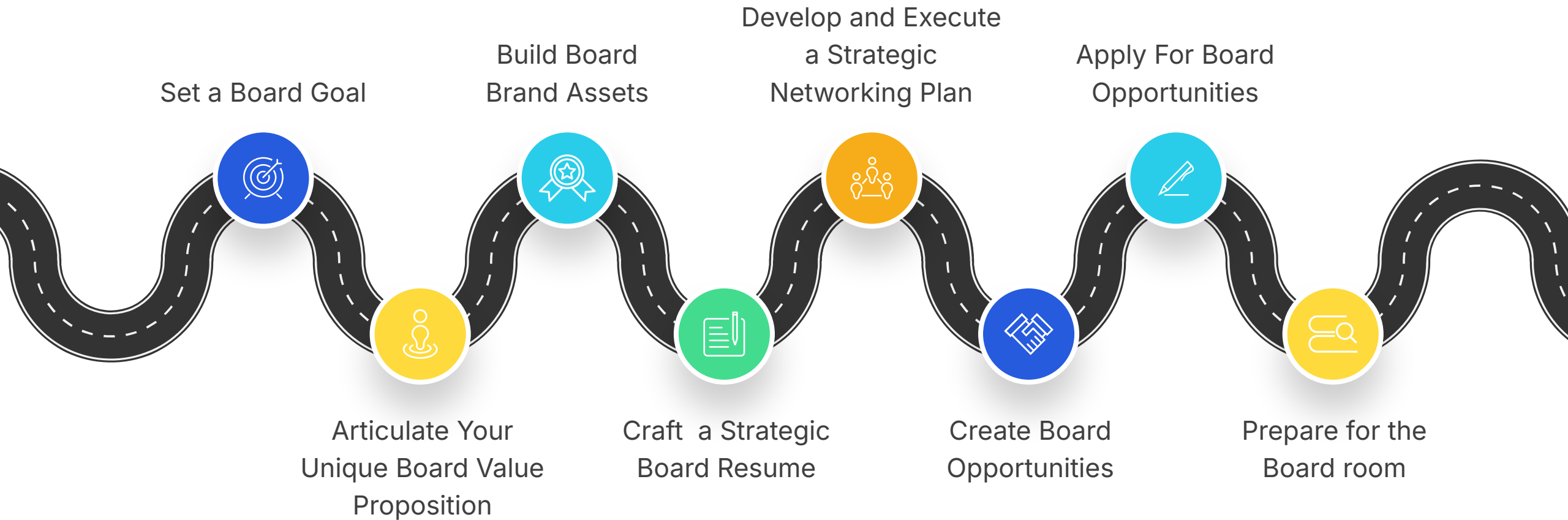
Determine a realistic destination:

Fill/Meet a skills gap/requirement = proven expertise (through demonstrating the business, strategic, and financial outcomes you've achieved)

Substance:

it's not just about holding qualifications or credentials

- ▶ Reputation + Credibility

- ▶ Cultural Alignment
- ▶ Other Sought-After Attributes

Start now, before you're "ready"



How to bridge the gap between your current experience and the needs of the Boards you aspire to



- ▶ **Skills gap analysis:** you and the Board Members. Find ways to close it



- ▶ Do things in your professional life that will help your Board life. E.g. build a network; establish a strong reputation and credibility; learn finances even if your role is far from finance; develop business acumen (the business of running a business + strategy).
